## TAC /25/007 -Discuss the purpose of the Tourism Advisory Committee and establish goals

- i. Cllr Winterbourne gave an overview of the previous Tourism Working Group and initiatives already discussed previously including Heritage Open Days and signage in the town. Cllr Winterbourne highlighted support available from the Civic and Community Committee for ideas the Tourism Advisory Committee want to develop.
- ii. Discussion about the need to recruit and engage more volunteers to support organisations in the town, as well as providing them with visible support and recognition. The areas of heritage and welcoming visitors to the town could be seen as a priority. Cllr Waples discussed a positive response for a volunteer call-out

- to assist with The Shack renovation project. Cllr Winterbourne advised that it is worth considering businesses that offer opportunities for their staff to volunteer in the community when it comes to recruiting volunteer assistance.
- iii. Discussion of the issue and challenges of gaining publicity for events to maximise attendees, including Heritage Open Days events, across the town. The need to attract more visitors to the town was also highlighted.
- iv. Discussion of funding avenues for tourism initiatives, and the enduring popularity of Stamford as a tourist destination.
- v. Discussion of existing Tourist Information avenues in the town.

#### TAC /25/008 -Update on maps and signage in the town

- i. Officer report on maps and signage in the town and overview of past discussions regarding the topic received.
- ii. Discussion on improvements that could be made to signage from the railway and available tourist information in the area. It was noted that a consistent approach/style is needed across the town in terms of the public maps available to be accessed by visitors.
- iii. Issue of noticeboard on Station Road having not been updated for years was discussed, with confusion about who owns it noted.
- iv. Discussion of the length of signage issues in the town and concern over the lack of a resolution.
